Nine ILI outbreaks in Negri Sembilan this year

SEREMBAN: A total of 15,225 influenza-like illness (ILI) cases have been reported in Negri Sembilan

from Jan 1 to July 9.
State health, environment, cooperatives and consumerism action committee chairman S. Veerapan said the Seremban district recorded the highest number of cases at 4,923, followed by Tampin (3,877), Jempol (2,255), Jelebu (2,050), Kuala Pilah (973), Port Dickson (824) and Rembau (323).

"There have been nine cumulative outbreaks of ILI recorded in the state this year and there are (cur-

rently) no active ILI outbreaks.

"There have been no closures of schools or kindergartens due to the outbreak, and no reported deaths," he said in a statement here yesterday.

He advised those at risk, especially senior citizens and children, to seek early treatment if they display symptoms such as fever, flu, cough and diarrhoea.

He also advised the public to regularly wash their hands and avoid visiting crowded places apart from practising proper coughing eti-quette. — Bernama

Khairy: Cabinet okays smoking ban bill

KUALA LUMPUR: The Tobacco and Smoking Control Bill was approved by the cabinet on Wednesday, said Health Minister Khairy Jamaluddin.

He said the bill would go before Parliament for debate in the upcoming session, which starts next Monday.

Monday.

Khairy said: "The tobacco bill was approved by the cabinet yesterday (Wednesday). We will be submitting it to Parliament for this session."

The proposed tobacco and smoking control law contains clauses to prohibit the sale of cigarettes, tobacco and vape products to anyone born after 2005.

Traders and cigarette vendors will not be allowed to sell smoking products to people covered by the ban.

Khairy previously said the proposed generational smoking ban was the next step towards reducing cancer cases and improving cancer treatment access in the country.

He also said once the law was passed, Malaysia would become the first country in the world to enact a tobacco generational endeame legislation

endgame legislation.
He said if nothing was done to overcome the smoking problem in the country, the habit would cost the government RM8 billion to treat lung cancer, heart problems and chronic obstructive pulmonary disease by 2030.

'Cabinet members, MPs need to support Khairy's proposal'

GEORGE TOWN: All cabinet members and members of parliament have been urged to unanimously support Health Minister Khairy Jamaluddin's proposal for a progressive law to eliminate smoking and possession of tobacco products for people born after 2005.

Consumers Association of Penang (CAP) president Mohideen Abdul Kader said if the law is enacted, it would create a healthy society and reduce the financial burden on the healthcare system.

"CAP welcomes and applauds Khairy's announcement (on the proposal of a progressive law to eliminate smoking and possession of tobacco products for people born after 2005).

"As such, we urge all cabinet members and MPs to unanimously support Khairy's proposal because, as he described, 'Malaysia will become the first country in the world to enact a tobacco generational endgame legislation'.

"It will be a momentous achievement for Malaysia, which started its tobacco control in the early 1970s.

The proposed tobacco and smoking control law contains clauses to prohibit the sale of cigarettes, tobacco and vape products to anyone born after 2005.

Traders and cigarette vendors would not be allowed to sell

smoking products to people covered by the ban. According to Mohideen, the

According to Mohideen, the government made a bad decision when it imposed a 10 per cent excise duty on all electronic and non-electronic cigarette products to raise revenue last year without considering the economic cost of treating chronic smoking-related diseases.

"The taxes earned from all tobacco products are minuscule compared with the estimated current expenditure of RM3 billion to treat chronic smoking-related diseases. The amount is projected to increase to RM8 billion by 2030.

"The claim by the tobacco industry that vaping is harmless and a way to take people off smoking tobacco products is baseless and self-serving.

baseless and self-serving.
"Studies have shown that vaping is unsafe as the aerosol contains heavy metals and other toxic chemicals as well.

ic chemicals as well.

"Vaping has been found to be more addictive, making it harder to cuit."

"Malaysia desperately needs a comprehensive tobacco control law to replace the current Control of Tobacco Product Regulations 2004 that, oddly, is placed under the Food Act 1983.".

Mohideen said without the tobacco industry's intense lobbying, the regulations would have been replaced by a standalone Tobacco Control Act in 2007. AKHBAR : THE STAR

Cannabis meds on sale by 2023

KJ: Cannabidiol products to be prescribed, not bought over the counter

KUALA LUMPUR: Registration of cannabidio (CBD) products is likely to begin next year with a frame-work on the registration of canna-bis products for medicinal use expected to be released sometime

expected to be released sometime this year, says Khairy Jamaluddin. "I target that next year, we can start registering a few CBD prod-ucts," the Health Minister said, add-ing that the National Pharmaceutical Regulatory Agency (NPRA) would analyse proposals on the implementation.

Mentation.

Khairy said factors such as the product's authenticity, safety and efficacy against certain conditions needed to be determined.

In addition to that, he said medi-

cal practitioners would also have to be trained to prescribe CBD for

medicinal use

"Once available, CBD has to be prescribed and cannot be bought

over the counter.

"For the time being, I am looking at prescribed CBD and not for self-medication. Recreational use of camabis is a far cry. it will be limi-ed to only CBD," he told reporters on the sidelines of the launch of The Centre's Drug Perception Study

Report yesterday.

"This is the first step. It is better we take cautious steps in line with international standards and scientific data.

Khairy also said the ministry would study the circumstances under which CBD could be pre-

On cultivation of the cannabis plant, he said it was not on the cards

by step," he said, adding that it was important to look at the response to

the products first.
"If the acceptance is huge and it is safe and efficacious, only then we can think about cultivation." He said he was convinced about

the evidence of the use for CBD for medicinal purposes.

He said the products would have to undergo clinical trials on their use for certain medical conditions, adding that talks would be held with researchers from local univer-sities including Universiti Malaya.

On another matter, Khairy said the Cabinet had approved the draft of the proposed Tobacco and Smoking Control Bill on Wednesday. "So, I will be sending it to Parliament for the coming meet-

ranatical for the colling ineeting," he said.

The proposed Bill has provisions to prohibit the sales of cigarettes, tobacco and vape products to those born after 2005.

The Dewan Rakyat will convene from July 18 to Aug 4.

Meanwhile, Persatuan Pengasih Malaysia president Ramli Abd Samad said while the announce-ment made by the Health Ministry to release the framework for the registration of CBD products next year was welcome, the rakyat must be properly informed about it first.
"Our current education on drugs

is creating a stigma towards the substance itself and the addicts including their family.

"When people hear 'cannabis', the first thing in their mind would be the negative effects of it, while in fact there are scientific proofs on its benefits," he said.

citing morphine as an example, despite being a dangerous sub-stance if used wrongly, it still pos-

sesses benefits as a painkiller. Ramli said CBD would be benefi Ramii said CBD Would be Lested-cial to some groups of people, espe-cially those who are suffering from terminally-ill diseases and mental health disorders.

Universiti Malaya's Centre for Addiction Sciences director Assoc Prof Dr Rusdi Abd Rashid said the government should speed up the government should speed up the permission to bring cannabis into the country for research purposes. Dr Rusdi, whose research is on the use of cannabis for autistic per-

sons with behavioural problems, said the delay would lengthen the time for him to finish his studies.

"I need the finished material. If the government does not allow the finished product to be brought in, I

cannot continue with the research.

"And the research would then take another two years before it can be prescribed to patients," he added.

Exercise key to overall health, wellness

PETALING JAYA: Exercise is important to maintain physical fitness and overall health and wellness, so why don't Malaysians

do it?

In the 2019 National Health and Morbidity Survey, 50.1% of the country's adult population were reported to be overweight (30.4%) or obcse (19.7%).

Similarly, the United Kingdom medical journal, The Lancet, pointed

to Malaysia as being the most obese country in Southeast Asia. But despite the staggering figures, why are some Malaysians still reluctant to exercise? Life coach Suraya Kulop said

Malaysians are reluctant to exercise due to their busy lifestyles, especially as the nation eases - towards post-Covid 19 recovery phase.
"Our habits are inter-related with

our mindset. When we were in lockdown, we started to exercise to motivate ourselves and occupy our time," she told the Sun.

She said it would take as much as 21 days of daily workouts to get into the habit of exercising.

"A simple exercise can mean a 20-minute brisk walk three to four ennes a week. Hormones such as endorphins, which are produced in our brain, are released when we move and this can improve our mood, which is good for our overall health." times a week. Hormones such as

Suraya said another reason behind the reluctance to exercise is that it is not seen as enjoyable.

Diettitian Reshmy Rance echoed this sentiment. She said most people.

do not care much about their health, until they are faced with a certain

diabetes until they or someone close to them has the disease. "There is a lack of information on

how to manage diabetes and the food (those affected) should avoid."

Reshmy said companies, have a responsibility to ensure their employees are healthy.

"There must be better ways to approach individuals besides organising health talks or producing pamphlets that are not updated.

"People should be encouraged to exercise."

Reshmy advised individuals to have a blood test done to determine

if they are diabetic or pre-diabetic. She cited a study released in 2020 in Penang, where 19,6% who were tested were found to be diabetics and 10.12% were pre-diabetics.

"Once an individual knows their bloodwork, they can seek the assistance of other professionals, like dietitians, to plan their meals and fitness trainers for exercise

Ministry to start registering cannabidiol products in 2023

KUALA LUMPUR: The Health

Ministry aims to register some cannabidiol (CBD) products in 2023. Its minister, Khairy Jamaluddin, said the framework for the CBD said the framework for the Cub product registration will be obtained this year and the National Pharmaceutical Regulation Agency (NPRA) will assess the proposals. "I foresee that we will be able to

begin the registration of several CBD products next year, but what's important isn't the product itself. We

need to see the veracity of the product data from safety aspects and

effectiveness against certain diseases.
"Education and scientific "Education and scientific exposure (on this matter) would need to be provided to medical officers in Malaysia," he said after the launch of a report titled *How Do* Malaysians Really Feel About Drugs? by The Centre, a think tank co-founded by Khairy that conducted a survey on 500 adults nationwide in April.

He also stressed that the use of CBD would be on prescription only would never encompass

recreational use.
"When we bring CBD in, it cannot be sold over the counter, it must be through prescriptions and what's important is that when the product is available, doctors know how to provide prescriptions." Khairy said the matter would take

some time as the ministry was being cautious and was viewing

international practices and scientific data on the use of CBD products.

He said the ministry would begin with assessing CBD product registrations, which is open to all,

registations, which is open to an, followed by clinical tests that encompass human trials conducted by Malaysian researchers.

The ministry is also having discussions with researchers from Universiti Malaya to have them conduct clinical trials on CBD use for medical conditions. - Bernama

Experts: Food inflation may expose children to obesity risk

KUALA LUMPUR: The current rise in food prices or food inflation, as well as supply chain issues, may disrupt access to proper balanced diets, according to experts who fear that this may

adversely affect people's health.

The B40 group, who are the most impacted by the inflation of food prices and who are forced to tighten their belts, may be compelled to make unhealthy compelled to make unhealthy food choices and experts fear that this may expose their children, in particular, to the risk of developing conditions such as obesity and diabetes.

diabetes.

There is existing data that points to a rather high prevalence of obesity among children from B40 households.

According to the National fleatth and Morbidity Survey 2019, the obesity and overweight rates among children from B40 families stood at 15.6% and 15.4% respectively.

respectively.

In comparison, the prevalence of obesity and being overweight among urban children stood at

15.3% and 15.4% respectively.

A person is considered obese if their body mass index (BMI) exceeds 30, and is overweight if their BMI ranges between 25 and 29.9.

BMI is calculated by dividing the person's weight in kilogrammes by their height in metres squared.

Malaysia Centre for Community Health Studies lecturer in the Nutritional Sciences Programme Prof Dr Ruzita Abd Talib said in the past, obesity was linked to high-income families who lived in cities and were exposed to an environment that contributed to

an intake of high-calorie food.

However, the situation has changed and even those living in rural areas and B40 families are facing obesity issues. "Obesity is high in states with

high levels of urbanisation such as Putrajaya due to supply guarantee factors in terms of food quality and quantity as well as environmental factors." - Bernama
