RM45.3B INJECTION FOR HEALTHCARE

It is the secondhighest allocated sum, which will be used to improve facilities nationwide

KUALA LUMPUR

HE Health Ministry received an allocation of RM45.3 billion to improve healthcare facilities nationwide.

The allocation was the second highest after the sum allotted to

the Education Ministry.
Prime Minister Datuk Seri Anwar Ibrahim said the money must be used to improve quality of healthcare and ensure comfortable, and people-friendly health facilities at all hospitals.

facilities at all hospitals.
He announced an allocation of RM1.35 billion for the maintenance of health infrastructure, including the repair of dilapidated hospital toilets and outdated patient wards.

The government will also continue to upgrade clinics across the country, he said.

He pointed out that under the Madani initiative, allocation for this purpose had been increasing every year — from RM100 million last year to RM150 million this year, and RM300 million next year.

WAR ON SUGAR

The prime minister said Malaysia had become known as the most obese nation in this region and there was a need for the people to cut their sugar intake.

To promote a healthy lifestyle and support the "War on Sugar" initiative, he said the government planned to gradually increase the excise duty on sugary drinks by 40 sen per litre starting

Revenue collected from this would be channelled to subsidise public healthcare, including for the purchase of medication and medical equipment to treat diabetes, as well as dialysis centres.

AFFORDABLE HEALTHCARE

A new partnership initiative will be introduced involving a collaboration with government-linked investment companies to provide affordable paid health-care services to patients.

care services to patients.

The implementation will start at five Health Ministry hospitals with high demand and suitable infrastructure, such as Cyberjaya Hospital, with an initial allocation of RM25 million.

Anwar said the government was also strengthening partnerships with 91 private hospitals to source patients from the Health Ministry for services such as cardiology, radiology, and nephrology.

"This approach indirectly creates a competitive element to secure the best prices for the government.

"The outsourcing will also continue with the National Heart Institute for heart patients among government retirees."

In addition, the government will implement an offtake policy or specific procurement from companies making new domestic investments to produce critical pharmaceutical products and medical devices.

"This approach not only sup-

"This approach not only supports the security of drug supply from local sources, but also has the potential to reduce costs in the medium term."

HEALTH CENTRES

OF EXCELLENCE RM100 million will be allocated

RM100 million will be allocated to improve health Centres of Excellence in the country, including funding for the latest equipment.

He said some of the best health experts in the country serve in government hospitals, including in Centres of Excellence.

APHM welcomes plan to outsource patients

KUALA LUMPUR: The Association of Private Hospitals Malaysia (APHM) has welcomed the proposal to outsource patients from public hospitals to receive certain treatments at 91 private hospitals.

Its president, Datuk Dr Kuljit Singh said APHM believed the amount was appropriate and sufficient to allow private hospitals to fully treat these patients, even under challenging conditions.

under challenging conditions.

"If at all possible, technology should be used to facilitate referrals between public and private institutions, saving patients from longer waiting time."

Kuljit also praised the government's proposal to reduce health subsidies for the top 15 per cent income group, describing it as a "positive approach".

He expressed APHM's willing-

ness to assist with the public hospital's private concept structure, suggesting the initiation of collaborative ventures and clinics where financially capable patients can receive treatment alongside private hospitals.

"This will enable the B40 and some M40 to receive public healthcare funding at a faster rate, while those who can afford it can receive treatment in a private initiative with a joint venture concent with private hospitals."

concept with private hospitals.

"It will also relieve the use of public infrastructure and human

He said this in response to Prime Minister Datuk Seri Anwar Ibrahim's announcement that the government is going to enhance collaborations with 91 private hospitals to outsource patients from public hospitals.

"We put in long hours when on-call working through the night and into the next day and had been expecting a higher increase.

"I hope the government can also look into other aspects of our welfare to compensate us better,"

The on-call allowance currently enjoyed by these medical officers ranges from RM80 to RM200

depending on the specialty.

When tabling Budget 2025,

War on sugar lauded, but absence of tobacco tax hike disappointing

TAXES on tobacco and smoking products should have been part of Budget 2025, health advocates say, as they welcomed the 40 sen hike to the sugar-sweetened beverage (SSB) tax

As part of the government's As part of the governments "war on sugar", Prime Minister Datuk Seri Anwar Ibrahim announced that excise duties on sugar-sweetened beverages will

sugar-sweetened beverages will be raised by 40 sen per litre starting Jan 1, 2025.

Anwar said the funds collected from the excise duties will be used for treatments and procurement of medicine supplies.

"It is concerning that no mention was made regarding tobacco duties."

Nevertheless, it is crucial that the government continues its efforts to combat tobacco con-sumption," said Federation of Malaysian Consumers Association (Fomca) chief executive officer

Saravanan Thambirajah.

However, he said the higher excise duties for SSB is a positive step towards tackling the alarming rise of non-communicable diseases such as diabetes and obesi-

"From a consumer perspec-tive, this policy aligns with public health goals, but it must be accompanied by complementary efforts to educate and encourage healthier consumption habits," healthier consumption habits,' he said.

he said.
"However, the increased reve-me from this sugar tax must be transparently reinvested into ini-tiatives that directly benefit public health."

Saravanan said the funds col-Saravanan said the finnes con-lected from the duties should be used on awareness and educa-tion campaigns and school nutri-tion programmes. He also proposed that healthier food be subsided to ensure those with low sugar content or sug-

with low sugar content or sug-ar-free options remain afforda-

Fomca tobacco and smoking control coordinator Muhammad Sha'ani Abdullah said the absence of a tobacco tax is very disappointing as the last increase was in 2015.

in 2015.

"While the government is struggling to raise funds, tobacco tax is an easy and right way to raise government revenue and pricier tobacco products would discourage smoking," he said.

Prof Dr Sharifa Ezat Wan Puteh, a health economics and public health specialist with Universiti Kebangsaan Malaysia's faculty of Medicime, said the SSB tax bike

Medicine, said the SSB tax hike may not be sufficient, adding that more input is needed in future increments.

Association of Private Hospitals Malaysia president Datuk Dr Kuljit Singh said the increase of excise duty on sugar will reduce consumption to some extent but continued education on the harm of excessive sugar intake is impor-

Cut waiting time at hospitals

'Upgrade rundown facilities and provide better services'

HAVING received the second highest allocation in Budget 202 stakeholders want the Health Ministry to heed the Prime Minister's reminder to upgrade rundown facilities and provide better services to the people, including reducing waiting time.

However, they conceded the allocation at RM45.3bil (a RM4bil increase from the previous budget) is still inadequate given the complexity and size of the service rendered by the ministry. Prof Dr Sharifa Ezat Wan Puteh,

a health economics and public health specialist with Universiti Kebangsaan Malaysia's Faculty of Medicine, said while some healthcare facilities are very rundown, funds should also be allocated for manpower as doctors and special-ists are needed to run these facili-

ies and attend to patients.

She said the RMI.35bil to upgrade dilapidated healthcare facilities and RM300mil for upgrade and repairs of dilapidat-ed clinics may not be enough as most of these facilities are already bursting at the seams with patient

She added that waiting time at healthcare facilities continues to

times there are shortages of treat-ment drugs and centres.

Hartal Doktor Kontrak spokes-person Dr Muhammad Yassin said while he agrees with the Prime Minister's call, it is more pressing to address the manpow-are shortage in bestifals.

er shortage in hospitals.

To tackle this issue as what
Hartal had mentioned many
times before, we need a Health Services Commission which has

the autonomy to hire its own staff based on the needs of the health-care sector," he added.

Meanwhile, Senator Dr RA Lingeshwaran said the RM1.35bil allocation to upgrade dilapidated healthcare facilities, including wards, is a great move as many public hospitals are more than 100 years old.

"In my home state of Penang alone, four out of six public hospi-tals namely Hospital Penang,

Hospital Balik Pulau, Hospital Bukit Mertajam and Hospital Sungai Bakap are all over a century old," he said.
"Some of the facilities can be

considered museum-grade hospi-tals and need to be urgently upgraded to render proper health

Former deputy health minister Datuk Dr Lee Boon Chye said to tackle the long waiting time at healthcare facilities, funds should be spent on digital technology, such as queue system and virtual consultation. consultation.

consultation.
"There was no special mention
of electronic medical records
(EMR) which will centralise
patient records. Hopefully, it will
be in the next Malaysia plan," he

EMR refers to a digital database system that enables healthcare facilities to keep track of relevant medical information such as registration, clinical laboratory results, pharmacy, nursing and kitchen information.

Govt to work with Sarawak to develop cancer centre

DETAILS on the proposed Sarawak Cancer Centre need to be worked out so that the project can be implemented soon, says Sarawak Deputy Premier Datuk Dr Sim Kul Hian.

"We are grateful to the Prime Minister and Health Minister for agreeing on the Sarawak Cancer Centres financial partnership, with Sarawak paying first and the federal government reimbursing later.

"We will need to get the federal government's technical and working committee to sit down and get the project going as soon as possible," he said.

He was responding to Datuk Seri Anwar Ibrahim's announcement when tabling Budget 2025 yesterday that Putrajaya would work with the state government to develop the Sarawak Cancer Centre, estimated to cost RM1bil.

He said a significant increase in funding is needed to repair dilapidated public health clinics and hospitals in the state, with the total cost estimated at RM17bil.

He said even with the Sarawak government's offer of RM50mil and a matching allocation from the federal government, it would take years for the repairs to be done.

On the plan to raise Sarawak's special grant to RM600mil, he said it is an interim solution pending a final formula in ongoing talks on the Malaysia Agreement 1963.
